WHAT WILL CHANGE?



NEW REQUIREMENTS FOR THE COMPOSITE PRODUCTS EXEMPTED FROM BORDER CONTROLS

Exempted 'composite products' (food containing both products of plant origin and processed products of animal origin) need to be shelf-stable, not containing processed meat and listed in the enclosed annex + meet the requirements of Article 3(1) (a) to (d).

NEW DOCUMENTATION FOR COMPOSITE PRODUCTS EXEMPTED FROM BORDER CONTROLS

Products meeting the above requirements (e.g. confectionery) will still be exempted from border controls but they will need to be accompanied by a private attestation.

IMPORTANT - The transition concerns ONLY certification requirements.

IT DOES NOT AFFECT THE APPLICATION of Articles 12, 13 and 14 of Regulation (EU) 2019/625 for composite products.

Your key action points

- Ensure all your colleagues in supply chain and customs roles are aware of the change
- Attestations must be signed by the Importer or your Broker
- Engage with your local import heath authority and clarify what this means regarding your import requirements?
- Speak to and obtain feedback from your BCPs how they will apply controls for attestations?
- Formal guidance will be issued by EU by end of month. Link to full regulation here.
- Prepare yourself for worst-case scenario as there is not much time.
- This is an EU regulation change. UK will continue to apply the current rules.
- IMPORTANT NOTE: This applies to all your 3rd country supplying markets i.e. not just the UK.

Potential Issues

What are the potential issues?

- General concerns that national customs are not prepared enough to deal with this new regulation. With Brexit, national customs officers are already dealing with a surge of imports of products with animal ingredients from outside the EU. We noticed that in many instances they were not properly informed and therefore requested the wrong documents. This led to delays and blockage. This might be even worse with the new regulation.
- The need to provide a private attestation for composite products exempted from border controls: while exempted products don't need to be accompanied by a certificate currently, they will need in future to be accompanied by the private attestation model. Although it's a self-declaration attestation, the level of details required is quite high (we might need to obtain information from suppliers).
- An evolving list of composite products: the list of composite products exempted from border controls (in annex) is not containing all the products that were exempted in the past. Despite meeting the conditions, these products (because they are not listed) might be subject to border controls until the Commission updates the list (which takes several months). It is unclear how these products will be treated until then (which documents will be required).





Frequently Asked Questions

What is the difference between a non shelf-stable and a shelf-stable composite product? A non shelf-stable composite product needs to be transported or stored under controlled temperature. It is not the case for shelf-stable composite products which can be kept at ambient temperature.

What percentage of a processed product of animal origin makes a food subject to the rules applicable to composite products? What makes foodstuff subject to the rules applicable to the composite products is the fact that it is made by both products of vegetable origin and processed products of animal origin. The percentage of processed product of animal origin included in the composite product is irrelevant

What is the main change to the rules applicable to the import of composite products into the EU from 21 April 2021 onwards? Import requirements are no longer based on the percentage of the processed products of animal origin in the composite product but rather on the animal health or public health risk linked to those ingredients of animal origin and on the need to tra
